The purpose and scope of the HISTORIC STAUNTON RIV-ER FOUNDATION is to promote, develop, and preserve the 1864 Battlefield at the Staunton River Bridge, the Staunton River Battlefield State Park, and the Staunton River and its historical areas.

Mr. Bob Moates Donates to Staunton River Battlefield State Park

Bob Moates of Charlotte Court House recently donated several items from his personal collection to Staunton River Battlefield State Park. These items will complement the Park's historical displays and programs.

Among the items Mr. Moates donated to the Park are two authentic railroad signal lanterns, which were used in the early 1900s. According to Jim Zanarini, Park Manager, these items will enhance the Park's Roanoke Station Visitor Center in Charlotte County, where they will be on display.

Moates, well known in the area as a historic re-enactor, also donated a wheelbarrow that he restored. It dates from the seventeenth century. Staunton River Battlefield State Park encompasses the Roanoke Station Visitor Center along with the Fort Hill battlefield area in Clover. The Roanoke Station Visitor Center exhibits focus on Native American life along the banks of the Staunton River, while the Clover Visitor Center contains exhibits on the War Between the States. The his-



toric Staunton River Bridge is part of a self-guided, rail-totrail that connects the two centers.

Antebellum Christmas Open House was a very "merry" success in December. Historic Mulberry Hill plantation with many of its original outbuildings was open in the first weekend in December. Highlights included a tour of the main house and grounds with do-

cents and guides dressed in period attire. Taffy pulling demonstrations and a Confederate encampment were enjoyed by many, as well as a visit from a jolly 'ol Santa with sweet treats and gifts. Attendance records were almost broken with close to 100 visiting over the weekend!



Park Given Kiosk



Virginia is the first state in the country to use outdoor interactive kiosks. Thirty-one of these new information systems have been installed in all of the Commonwealth's parks. Several months ago, Virginia State Parks Director Joe Elton and Virginia Secretary of Natural Resources L. Preston Bryant, Jr. were present at Staunton River Battlefield State Park as part of a Virginia Board of Conservation and Recreation meeting, that featured demonstration on the interactive kiosks.

"It is a one-of-a-kind system in the world. We hope these new systems will entice the public and also break down many barriers that often separate them from nature," stated Elton. The



user-friendly information stations feature touch-screens that allow park visitors to access GPS-based trail information, wildlife spotting guides, information on specific park amenities, programs, descriptions, schedules, and much more. Customizable maps that highlight features like biking, hiking, or wildlife viewing can be printed onto thermal paper with waterproof ink. Interactive virtual tours of every park throughout the state are also accessible. These systems are being provided at no cost to the public. Dominion, one of the largest producers of energy headquartered in Richmond, is the principal sponsor.

The systems have been tested to handle extreme temperatures ranging from -27 to 95 degrees and they contain internal air conditioners to remove moisture and to keep them cool. The easy-to-use touch screens are made of bulletproof glass surrounded by heavy-duty coated enclosures.

8pm-Dusk: Wagon Ride and Tour of the Battleground will depart from Fort Hill at 8pm. Please arrive a few minutes early and please bring a flashlight.

Dusk: Night Cannon firing demonstration by Cumming's Battery/Cape Fear Light Artillery in Fort Hill.

Saturday, June 23, 2007

Tentative Schedule

9:00am – 10:00am: Military Service Award Ceremony at Fort Hill near UDC monument, presented by the Halifax Chapter of the United Daughters of the Confederacy and the Historic Staunton River Foundation. These service awards are presented to veterans who are lineal descendants of Confederate veterans. The Historic Staunton River Foundation will present commemorative medals to recognized descendants of the participants of the Battle for the Staunton River Bridge.

10:00am –1:00pm: Members of the Sappony Indian Nation will be present at Roanoke Station in Randolph with displays pertaining to their heritage and history. Sappony will demonstrate wood carving methods and the art of using a blowgun. In addition, Sappony food and merchandise will be available for purchase.

10:30am-12:00pm: Guided Battlefield tour and narration. The walking tour will begin at the Roanoke Station in Randolph and conclude at the Clover Visitors Center. Parking is available at both locations, and a bus will be provided for transportation.

11:30am: Lunch - Hotdogs, BBQ, chips, and beverages will be available for purchase at the Picnic Shelter at the Clover Visitors Center.

1:00pm – 1:30pm: "Jeff Davis and the White House of the Confederacy," a lecture presented by Abdur Ali-Haymes in the Conference Room of the Clover Visitors Center. He joined the staff of the Museum of the Confederacy in 2000 after spending 30 years in the army as a Command Sergeant Major. He is a native of Halifax County.


1:30pm – 2:00pm: Sam Craghead, Marketing Outreach Specialist for the Museum of the Confederacy, will speak in the Conference Room about the expansion of the museum that will be coming to Appomattox.

Throughout the day: Living History Encampment presented by Confederate re-enactors from the 14th Virginia Infantry, Co. K, Oliver's Battery, 21st Virginia Artillery, Co. C, and the 23rd Virginia Infantry, Company I, Central Guards will be located next to Fort Hill.

Throughout the day: Cannon firing demonstrations by Cumming's Battery/Cape Fear Light Artillery in Fort Hill. A "firing schedule" will be available in the Clover Visitors Center.

The Staunton River Fight



After a march of 32 miles due east, the command halted for the right, near Oak Grove. A march of 88 miles brought them to the Iron bridge, across Stony creek, here they had a severe engagement with the rebels, losing heavily, and at Reams' Station, which Wilson supposed was in the possession of the Yank's, he found Mahone across his line of retreat, when abandoning his artillery, ambulances, wagons, &c, by a wide detour avoided the rebels and regained their own lines." (From History 1st D.C. Cavalry)

As soon as this charge had been repulsed all of the troops in the ditches on the Halifax side of the river were hurried across to the Charlotte side, and stationed along the riverbank. This movement of troops from one side to the other gave strength to Mrs. McPhail's statement of the arrival of re-enforcements.

INCIDENTS OF THE BATTLE

The artillerists on the enemy's side were regulars, and said to be the best marksmen in the Northern army. They threw a perfect shower of shot and shell right down on us in the fort, and about ten steps back =from the earth-works, the ground was fairly swept with deadly missils. Right here, Mr. Paul McPhail, who was a sort of a staff officer or courier for Col. Farinholt, met the Colonel with a verbal message of some sort. They were not more than fifteen steps from the writer, Paul had hardly commenced the delivery of his message when over came a shower of shells, and one bursting right in front of them completely hid them from view in the dust and smoke. Immediately, above the din and roar of battle was heard a voice: "Dar now, Old Farinholt done killed." So I thought, but when the smoke cleared away, Col. Farinholt was standing as if nothing unusual had happened. Paul was somewhat excited, if one might judge from his wide gesticulations.

Just as the enemy's shot and shell began to fall thick and fast around us, and before they were in range of any of our pieces, in a ditch just above the bridge – Halifax side – and down to the river bank, were heard these words: "Let us pray." Here were stationed the Drakes Branch Home Guards, composed entirely of graybeards and commanded by Capt. Henry E. Vaughan, and the above words were uttered by Rev. W. T. Gilliam, and was followed by an earnest appeal to God of battles to be a shield and protection to them all and let non falter or fail to go where duty might call. This company marched bravely across the bridge to the Charlotte side at the word of command, held another season of prayer before laying down on their arms for the night, arose the next morning and again invoked the Divine protection and aid. They laid claim to more than one dead Yankee, found on the field of battle, and Mr. Wm. G. Friend captured a live and unhurt Yankee on the field of battle. Rev. W. T. Gilliam, Rev. Dr. H. A. Brown, Rev. Jno. D. Southall, with their respective Deacons, Elders, and Class leaders made up the rank and file of this Company. Was there ever another such Ministers and Deacons meeting held in old Virginia?

The killed on our side, were Dr. Sutphin, whose head was shot off at the rail pen in the ditch parallel to the rail-road, Rev. Mr. Burke, whose head was shot off by solid shot directly under the abutment of the bridge on the Charlotte side. A young man fell between the fort and bridge, shot through the thigh and bled to death. Of the enemy there were about sixty left dead on the field.

Annual Meeting

The Foundation held its Annual Meeting in the Clover Visitors Center on Thursday, October 4. The pot-luck-supper was enjoyed by many Foundation members and volunteers. Following a great meal, Dr. Thomas Wessells, Jr., spoke on his book, <u>The Biography of Colonel Benjamin Lyons Farinholt, CSA</u>. His informative book discusses the "fate that placed Farinholt in the center of major events from the siege of Yorktown to the surrender at Appomattox....[Farinholt] met with Lee and Davis....was commander of the post

at Staunton River Bridge in 1864 and saved Lee's only supply line to Richmond and Petersburg." Following his presentation, Dr. Wessells answered questions and autographed copies of his book.
